**Things you need to know:**

- ❖ Call 540-387-6256 or check [www.ghpec.org](http://www.ghpec.org) by 9:00 a.m. on show date if weather is questionable. A message will be on the answering machine if show is cancelled.
- ❖ No Concessions available at the winter series shows!
- ❖ Dogs must be on a leash at all times. This is a Roanoke County Parks & Rec regulation and will be enforced.

- ❖ Driving directions: I-81 to exit 137, exit right ½ mile onto Rt. 619 (Wildwood Rd). Right at traffic light onto Rt. 11 South (460W & West Main) and go ¾ mile. Turn left onto Rt. 639 (Diuguids Lane) at traffic light. ALL TRAILERS: Entrance 1 mile on right. ALL OTHER TRAFFIC: Entrance 1 ¼ miles on right.
- ❖ Helmet required in youth games. Protective/safety equipment will not be penalized.

- ❖ Va Dept of Agriculture requires all horses on show grounds to have a current (within 12 months) negative coggins.
